- All digital color and greyscale artwork must be supplied at 300 dpi. Line art must be supplied at 600 dpi.
- File formats accepted are: High-res PDF, EPS, TIFF and JPEG files. Software such as Microsoft Word, Publisher, Photoshop, Adobe Illustrator or InDesign can also be used if fonts are embedded or saved as PDF or PS files.
- All color artwork must be in CMYK mode; black-and-white artwork must be in either greyscale or Bitmap mode. RGB mode artwork is not accepted and if supplied will be converted to CMYK mode, which will result in a color shift.
